#### **Limited Public Comment**

Doug Tripp asked how to get a road fixed. The manager discussed how we are funded through the Michigan Transportation Fund. The primary and local road policy was also discussed.

Commissioner Ingles inquired on how to answer questions at township meetings on gravel roads and deburming questions. The manager advised that we don't deburm gravel roads unless the township puts gravel back down.

Rick Gripman asked what the Michigan Transportation was based on. Mr. Sanders discussed how the funding is distributed.

Jack Mosley asked of the status of the driveway easement on Ash-te-Wette. Discussion followed on the attorney's advice. Mr. Sanders will reach out to the other resident involved to attend the next board meeting. A decision will be made at the next meeting on June 3<sup>rd</sup>.
