1. Montgomery Road Bridge - Federal Aid (30000-133159)

- All field work completed on Project, coordinating with Contractor & MDOT to balance remaining pay items on the Contract.
- Project expected to close 2.39% below the original awarded contract amount.
 - Original Awarded Contract Amount = \$854,683.84
 - Current Net Total = \$834,232.10
- Will coordinate with MDOT over the next month on closing the project out

2. Dennings Road Culvert

- Surveyed on September 14th, plans and EGLE permit application submitted on September 22nd
- Proposed culvert 5 foot in diameter at 50 feet in length, skewed to align with existing stream

3. Beecher Road Culvert

- Voluntary Transportation Review submitted to EGLE on September 8th, waiting for meeting with EGLE
- Surveyed on September 14th

4. Elm Road Bridge

- Surveyed on September 14th
- EGLE identifies bankfull width at 11ft, existing structure width is 16 ft
- Mussel Shells found on site, will need to request quotes for mussel survey
- Will need to coordinate with replacement options. Timber bridge or box Culvert.

5. Camden Road Culvert

- Surveyed on September 15th
- EGLE identifies bankfull width at 21ft, existing structure width is 25 ft
- Will need to coordinate with replacement options. Timber bridge?
